1. Defendant/Plaintiff Relationship: The defendant has been elected to represent the plaintiff in a representative form of government and is obligated under the oath of office and the Constitution to do so in a fair and just manner.
2. There are no pending actions in the State but there are pending matters in the Federal system.
3. The plaintiff has requested such equal representation before from said elected representatives but so far has not received it.
4. I need a Court Order because: (Check the box or boxes that apply to you):
 - o More money is devoted to boys' education and sports than girls;
 - o An academic paper with a male name receives higher scores than that with a female name even if the content is identical;
 - o Medical care is denied to women, which is not denied to men;
 - o Insurance coverage is denied to women, which is not denied to men;
 - o Everything from haircuts to dry cleaning costs more for women who make 83% of what a man makes in the marketplace with the same qualifications;
 - o Upon marriage I and the children are expected to take the name of the father, a relic of ownership of women and children;
 - o During marriage I do 90% of the housework and home maintenance;
 - o During marriage, I carry the burden of child rearing but upon divorce, according to a study done in Arizona in 2003, and verified by national data from the National Judges Foundation, if a man asks for custody, he wins the majority of the time especially if he is violent;
 - o Upon divorce, the man's income increases more than 70% while the woman's decreases more than 80%;
 - o Ninety percent of domestic violence is committed by men toward women;

- o According to a study in Arizona in 2003, men are rarely arrested for such violence but when they are, the more serious the violence, the less harsh the punishment;
- o Most murders between partners are by men murdering women;
- o Arizona was number four in the nation for intimate murders of women in 2009;
- o Rape is a singular crime directed by men toward women;
- o Men are overwhelmingly the pimps and johns who abuse women they prostitute; yet women are overwhelmingly the ones arrested;
- o Girls and women comprise 80% of humans who are trafficked;
- o Women prisoners and detainees are shackled during birth, which constitutes inhumane treatment and torture causing harm to both the woman and child;
- o Elder women disproportionately suffer from poverty and cuts in Medicare, Medicaid and Social Security will harm them;

6. Defendant should be ordered to (check all that apply):

- o Pass the Fair Pay Act;
- o Enforce the Lilly Ledbetter Act;
- o Cease and desist from all attacks on reproductive rights including abortion;
- o Make available over the counter abortion medication;
- o Cease and desist production of rohypnal, the date rape drug;
- o Fully prosecute rape, sexual assault and sexual harassment;
- o Pass and enforce rape shield laws that focus responsibility on the criminal not on the victim;
- o Actively enforce Title IX prohibiting discrimination in education and sports between girls and boys;
- o Fully fund our public schools, including civics classes, physical education, arts and music to restore our democracy to a healthy and vibrant one;
- o Cancel all school voucher programs that shuffle state monies to private parochial schools that by their nature preach inequality and violate the First Amendment Separation of Church and State;
- o Pass the Equal Rights Amendment with only three more states needed;
- o Ratify the Convention on the Elimination of Discrimination of all Forms of Discrimination Against Women waiting since 1979;

- o Expel Scott Bundgaard from the Arizona Senate for committing domestic violence and thus expressing publicly his belief in the inferiority of 53% of his constituents, women;
 - o Vigorously collect all child support;
 - o Enforce the statute that prohibits granting custody or unsupervised visitation to parents who have physically or sexually abused their children or the other parent;
 - o Vigorously enforce the Brady and Lautenberg gun laws to prevent those who commit domestic violence or have mental health problems from obtaining weapons;
 - o Mandate anti-rape education among all males starting in elementary school including a White Ribbon campaign in Arizona;
 - o Cease and desist from arrests of minors for prostitution; instead put the focus on the adults who are committing child abuse by having sex with children;
 - o Adopt the Swedish Model prostitution law focusing on demand;
 - o Comply with federal law that all persons under 18 who are prostituted are trafficking victims and not criminals;
 - o Pass a law prohibiting shackling of women during labor and birth;
 - o Make no cuts to Medicare, Medicaid or Social Security;
 - o Make cuts to the Pentagon and war budget;
 - o Pass tax laws that make the wealthy pay their fair share;
 - o Pass laws that repeal Citizens United making corporations persons.
7. o If checked, because of the risk of harm, no defendant should be allowed to possess arms or ammunition.
8. o If checked, request an order for the defendant to participate in consciousness awareness raising discussion groups run by NOW;
